## **TERMS OF BUSINESS FOR THE INTRODUCTION OF PERMANENT STAFF TO BE DIRECTLY EMPLOYED BY THE CLIENT DEFINITIONS**

### **Applicant**

Means the person introduced by the Company to the Client for an Engagement including any members of the Company's own staff.

### **Client**

Means the person, firm or corporate body together with any subsidiary or associated company as defined by the Companies Act 1985 to whom the Applicant is introduced.

### **Company**

Means JUICE Resource Solutions Limited of 3 Soothouse Spring, St Albans, Hertfordshire, AL3 6PF.

### **Engagement**

Means the engagement, employment or use of the Applicant by the Client on a permanent or temporary basis, whether under a contract of service or for services, under an agency, licence, franchise or partnership agreement, or any other engagement.

### **Introduction**

means the Client's interview of an Applicant in person or by telephone, following the Client's instruction to the Company to search for an Applicant, or the passing to the Client of a curriculum vitae or other information which identifies the Applicant and which leads to an engagement of that Applicant by the Client.

### **Remuneration**

includes base salary, guaranteed and/or anticipated bonus and commission earnings, allowances, inducement payments, the benefit of a company car and all other payments and taxable (and where applicable non-taxable) emoluments payable to or receivable by the Applicant for services rendered to or on behalf of the Client.

### **1.2**

Unless the context requires otherwise, references to the singular include the plural and references to the masculine include the feminine and vice versa.

### **1.3**

The headings contained in these terms are for convenience only and do not affect their interpretation.

## **2. THE CONTRACT**

### **2.1**

These Terms of Business are deemed to be accepted by the Client by virtue of an Introduction to, or the Engagement of an Applicant.

### **2.2**

Unless otherwise agreed in writing by the Principal of the Company, these Terms of Business shall prevail over any other terms of business or purchase conditions put forward by the Client.

### **2.3**

No variation or alteration of these terms of Business shall be valid unless approved in writing by the Principal of the Company.

## **3. NOTIFICATION AND FEES**

### **3.1**

#### **The Client agrees:**

#### **a)**

To notify the Company immediately of any offer of an Engagement which it makes to the Applicant;

#### **b)**

To notify the Company immediately that its offer of an Engagement to the Applicant has been accepted and to provide details of the Remuneration to the Company; and

#### **c)**

To pay the Company's fee within 30 days of the date of invoice.

### **3.2**

No fee is incurred by the Client until the Applicant commences the Engagement when the Company will render an invoice to the Client for its fees.

### **3.3**

The Company reserves the right to charge interest on invoiced amounts unpaid for more than 45 days at the rate of 2.5% per annum above the base rate from time to time of Barclays Bank plc from the due date until the actual date of payment.

### **3.4**

The fee payable to the Company by the Client for an Introduction resulting in an Engagement is the amount equal to 20% of the Remuneration applicable during the first 12 months of the Engagement by the Client where the salary is £39,999 or less. Where salaries are £40,000 or over the fee payable is 25%. VAT will be charged on the fee if applicable.

## **4. REFUND GUARANTEES**

### **4.1**

In order to qualify for the following guarantees, the Client must pay the Company's fee within 14 days of the date of the invoice and must notify the Company in writing of the termination of the Engagement within 7 days of its termination.

### **4.2**

If the Engagement terminates before the expiry of 12 weeks from the commencement of the Engagement (except where the Applicant is made redundant) the fee will be rebated in accordance with the accompanying Scale of Rebate.

### **4.3**

If, after an offer of Engagement has been made to the applicant, the Client decides for any reason to withdraw it, the Client shall be liable to pay the Company a minimum fee as indicated on the Scale of Rebate.

### **4.4**

Should the Client or any subsidiary or associated company of the Client subsequently re-engage the applicant within a period of 6 calendar months from the date of termination of the Engagement or withdrawal of the offer, a full fee calculated in accordance with clause 3.4 above becomes payable, with no entitlement to the refund.

Scale of Rebate:

1/2 weeks	100%
3/4 weeks	80%
5 weeks	70%
6 weeks	60%
7 weeks	50%
8 weeks	40%
9 weeks	30%
10 weeks	20%
11 weeks	10%

There will be no refund where the Applicant leaves during or after the 12th week of the Engagement.

## **5. INTRODUCTIONS**

### **5.1**

Introductions of Applicants are confidential. The disclosure by the Client to a third party of any details regarding an Applicant introduced by the Company which results in an Engagement with that third party within 6 months of the Introduction renders the Client liable to payment of the Company's fee as set out in Clause 3.4 with no entitlement to any refund.

### **5.2.**

An introduction fee calculated in accordance with clause 3.4 will be charged in relation to any applicant engaged as a consequence of or resulting from an introduction by or through the Company, whether direct or indirect, within 6 months from the date of the Company's introduction.

### **5.3**

In the event that an employee of the Company with whom the Client has had personal Dealings accepts an Engagement with the Client within 3 months of leaving the Company's service the Client shall be liable to pay an introduction fee to the Company in accordance with clause 3.4.

## **6. SUITABILITY**

### **6.1**

The Company endeavours to ensure the suitability of any Applicant introduced to the Client. Notwithstanding this the Client shall satisfy itself as to the suitability of the Applicant and shall take up any references provided by the Applicant and/or the Company before engaging such Applicant. The Client shall be responsible for obtaining work and other permits if required, for the arrangement of medical examinations and/or investigations into the medical history of any Applicant, and satisfying any medical and other requirements or qualifications required by law of the country in which the Applicant is engaged to work.

**LIABILITY**

**7.1.**

The Company shall not be liable under any circumstances for any loss, expense, damage, delay, costs or compensation (whether direct, indirect or consequential) which may be suffered or incurred by the Client arising from or in any way connected with the Company seeking an Applicant for the Client or from the introduction to or Engagement of any Applicant by the Client or from the failure of the Company to introduce any Applicant. For the avoidance of doubt, the Company does not exclude liability for death or personal injury arising from its own negligence.
